Spiny Dogfish Workgroup Meeting

- Increase the state waters vessel trip limit to 10,000 lbs if the absent members are ok with it.
- Set vessel trip limits for Atlantic Striped Bass Permit Owners to be 2,500 lbs if the absent members are ok with it.
- New Entrants Application with Criteria, ranking could be based on:
 - Owning a vessel (already required to have a spiny dogfish permit)
 - Spiny dogfish bycatch landings
 - Owning a striped bass permit because they are encountering spiny dogfish anyway
 - Number of state or federal permits
