Sarah Widman, DNR Fisheries, gave an overview of some recent penalty items.

The Interstate Wildlife Violators Compact which Maryland is a signatory of will be going into full effect soon. Maryland had to wait for the e-license system to be changed in order to be able to suspend all individuals listed under this compact. Those changes are being made and more public outreach will occur as the system goes into effect.

The NRP will be moving towards an e-ticketing system similar to the MSP. This is scheduled to be phased in over the next year or so. In order to have this system, all violations (subsections of law) must be listed out in the fine schedule. The fine schedule has been redrafted to break it out into each individual subsection of law. Because of these changes, Sarah asked that commissioners bring forward only those fines they would like to see changed. There was a discussion of herring fines and ultimately it was suggested that no changes be made.

It was also discussed that because e-tickets will look different and each subsection of law is listed, the penalty schedule or fine schedule may need to be changed in order for the two systems to correctly correspond to each other. Commissioners suggested perhaps making separate fine tiers for 1,2,3 fish and then continuing on with the rest 4-6, 7-10, etc. This will be the case for any violation that is enumerated (number of gear, distance or number of fish).

The group also discussed adding criminal theft related activities to the fine schedule so that regardless of whether someone is charged with criminal theft of fishing gear or fish or something under natural resources law, they will be suspended.

The group then discussed the penalty schedules.
