Timeline

Implementation Goal: November 1, 2013

- Draft regulations, take them to the public for input by April/May 2013
- Propose regulations by July 1, 2013
- Regulations would be effective by late October 2013





Spiny Dogfish Industry Meeting

Work Plan – What will the Workgroup do?

Each Meeting will cover a topic that will need to be addressed while reviewing the design of the fishery

- -Control dates: Who is included?
- -Landings data: What's the source?
- -Limited Entry: What does it look like? Qualifications?
- -Process: transfers, declarations, permits, rollovers, etc
- -Cost recovery and enforcement





Spiny Dogfish Industry Meeting

Guidelines / Ground Rules

Motions:

- Work group members should make a motion when recommending action to Fisheries Service, e.g. Jeff Eustler motions that Fisheries Service consider making the spiny dogfish fishery limited entry. Motion is seconded by Sonny Gwin.
- Discussion will follow and will be limited to the merits of the motion.
- Motion should be approved by the majority. A tie or a failed motion provides us as much information as a passed motion.
- Will need to document reasons why passed, failed, or tied. If not unanimous, the work group should report on all reason(s) for the dissenting vote.

- One workgroup member will speak at a time. Please raise your hand, and we (the facilitators) will ensure each member has an opportunity to talk.

Spiny Dogfish Industry Meeting

Parameters: Fisheries Services' Management Principles

- Sustainability
 - Provides for long-term availability of the fisheries resource
- Accountability
 - Harvest reporting/accounting is transparent
- Cost Recovery
 - The cost of managing the fishery (permits, quota monitoring, etc) is covered by the industry – the state does not incur any additional cost
- Enforceability
 - The laws and regulations do not require additional man power, and compliance is easily verified





Spiny Dogfish Industry Meeting

Proposed Spiny Dogfish Workgroup Objective: Recommend regulations to the Department that meet their principles and meet the industry's goals.

Spiny Dogfish Workgroup Goals:

- provide a sustained winter fishery from November April
- no ITQs
- protect local, active fishermen
- maintain flexibility

Future discussions may bring up other goals that were not part of previous discussion.

Limited Entry: What Does it Look Like? Qualifications?

What we have heard so far:

- Follow federal spiny dogfish fishery vessel rules
 - Eliminates complications resulting from vessel ownership
 - Corporations/multiple people owning a share
 - Consistency
 - Require a federal spiny dogfish permit
 - Ever? Consistently for the selected landings period?
 Must the vessel always be in possession of a federal permit?

Limited Entry: What Does it Look Like? Qualifications?

What we have heard so far:

- Locals only
 - Cannot possess an out of state spiny dogfish permit.
 - Excludes VA state permit holders
 - Allows DE watermen
 - OC harbor requirement
 - How would this work?

- Tiered system that could allow for bycatch by people that did not qualify for limited entry.
 - Group A Qualifications?
 - Group B Qualifications?
