# Harris Creek

- Tributary Plan oyster goal 377 acres, but only 326 suitable for restoration
- 2014: 105 acres- 62 (*DNR*), 23 (*Army Corps*), 20 *seed-only* (*ORP*)
  - Total to date in Harris Creek 289
- Planned for 2015: 37 acres (*Army Corps*), *finish spat-on-shell deployment* (*ORP*)
- Total 326 acres by end of 2015

# Little Choptank River

Tributary Plan oyster goal 221 acres

2014-15: granite- 214,800 tons, *fossil shell 57,585 tons*- total 182 acres by early 2016

# Fossil shell

- To date- 10 trains, 50,000 tons of fossil shell planted










