Dear Commercial Striped Bass Gill Net Fisherman;

The purpose of this letter is to inform you that the 2011 Commercial Striped Bass Gill Net season will re-open on Tuesday, December 6th. Open fishing days will be Tuesday, Wednesday and Thursday each week with a daily permit allocation of 300 Lbs./day. The Gill Net fishery will remain open through Thursday, December 29th, unless the Department determines that the monthly quota will be harvested prior to the December 29th. **Please note:**

- **Notifications of closures and/or modifications to open fishing days and daily limits will be made via public notice. Check Stations will also be made aware of any changes to the fishery.**
- **You will not be receiving a new permit card at this time.**

You were issued a permit in January that was valid for the entire calendar year season (January – February and December). Your gray 2011 permit card and maroon tags EXPIRE ON December 31, 2011. If you declared for the 2012 Chesapeake Bay Gill Net and Hook & Line combination you will receive your 2012 permit card and 2012 red gill net tags prior to January 1, 2012. Please do not use the 2012 permit card and red tags until January 1.

Additional 2011 striped bass tags will not be sent at this time. If you need tags, please fax a copy of your permit card to (410) 260-8279.

Please be sure to read the notification included with this letter regarding regulatory changes that will affect the Gill Net fishery. If you have any questions please call Matt Lawrence at (410) 260-8293.
