Chesapeake Watershed Agreement (June 2014)

- Purpose: Continue protection & restoration efforts
- Who: Chesapeake Bay Program = Regional Partnership
 - 6 Bay States (MD, VA, PA, NY, DE, WV)
 - District of Columbia
 - Chesapeake Bay Commission
 - Federal Government (EPA, AG, Commerce, Defense, Homeland Security, Interior & Transportation)
- Vision: ".....an environmentally and economically sustainable Chesapeake Bay watershed with clean water, abundant life, conserved lands and access to the water, a vibrant cultural heritage and a diversity of engaged citizens and stakeholders."




Key Components

- Although a "voluntary" agreement signatories are committed to core values & willing to take action to advance restoration and protection of Chesapeake Bay & tributaries
- Agreement consists of 31 interconnected outcomes
 - Outcomes = specific, time-bound, measurable targets
- 25 Management Strategies
 - outline steps to achieve outcomes
- Seeking public input on draft Management Strategies
- Open public comment: March 16 April 30 (special extension to May 11th for TFAC comments)

 - Assessing Progress
 - Adaptively Managing
 - Biennial Workplan (will be developed by December 2015)

Blue Crab Abundance & Management Outcomes

Sustainable Fisheries Goal: "Protect, restore and enhance finfish, shellfish and other living resources, their habitats and ecological relationships to sustain all fisheries and provide for a balanced ecosystem in the watershed and Bay"

Blue Crab Abundance Outcome: "Maintain a sustainable blue crab population based on the current 2012 target of 215 million adult females. Refine population targets through 2025 based on best available science"

Blue Crab Management Outcome: "Manage for a stable and productive crab fishery including working with the industry, recreational crabbers and other stakeholders to improve commercial and recreational harvest accountability. By 2018, evaluate the establishment of a Bay-wide, allocation-based management framework with annual levels set by the jurisdictions for the purpose of accounting for and adjusting harvest by each jurisdiction"



Management Strategy Timeline

- Open public comment period March 16 April 30, 2015
- Incorporate comments
- CBP Management Board review
- Principal Staff Committee review May 1 June 29, 2015
- Final Management Strategies released June 30, 2015
- Goal Implementation Teams develop 2-yr work plans July 1-Dec 14
- First biennial work plan due December 15, 2015
- Next updated work plan December 2017
