- Hook & Line ITQ commission agreed to move the discussion regarding complaints of charter boats running paid charters while participating in the commercial hook & line fishery to the striped bass workgroup.
- Department asked the commission to assist with informing pound netters who are not activating their nets prior to fishing and reporting.
- Commission requested that the Department meet with Pound Netters to discuss allocation options being developed by ASMFC for inclusion in Amendment 3 (Menhaden allocation).
- The Commission requested that the Department send notices to the watermen that have reported pound net harvest last license year but had not activated a pound net. Since this request, the subject was brought up at the Striped Bass Workgroup and there was a request to send a notice to all watermen with registered pound net sites. The Department is going to send both types of notices. Those with reported harvest will receive a letter specific to their harvest. Other registered pound net holders, will receive a postcard as their FINAL reminder of this regulation and requirement.

• Striped bass allocation – pro's and con's of various options to reach 100% quota capacity. Commission agreed to move the discussion to the striped bass workgroup.
